Question #1. Page 88, Attachment A, Labor Category Qualifications, states the requirement for a Bachelor's Degree under both the Staff and Junior Staff labor categories. The Table of Labor Category Qualifications and Equivalencies provided on page 89 indicates a BS degree under the Degree column for these two categories. Is a Bachelor's Degree acceptable or is a Bachelor of Science Degree required? Page 89, Attachment A, Table of Labor Category Qualifications and Equivalencies, lists a BS under the Degree column for the Senior Staff labor category. Is a Bachelor's Degree acceptable or is a Bachelor of Science Degree required?  
Answer #1. The Table of Labor Category Qualifications and Equivalencies on Page 89, under Degree, should state that a BS/BA degree is acceptable for each labor category where only a BS degree was previously referenced.  
 Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
